To prepare schedule to organize Peer Team Visit of NAAC to be held on 7th and 8th September 2018

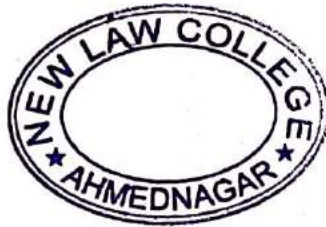


To Celebrate 2019-2020 as Golden Jubilee Year of the College
